

III—GENERAL ASSEMBLY—OVERALL VOTES

This section contains tables of the 105 Plenary votes that were recorded at the 61st session of the UN General Assembly (UNGA) plus one Third Committee vote and two emergency special session votes. Of these 108 votes, 85 pertained to resolutions as a whole, 16 to separate paragraphs, three to decisions, and four to no-action motions. Of the total 108 votes, the United States voted Yes 17 times and No 77 times; it abstained on 14 votes.

COMPARISON WITH U.S. VOTE

The tables that follow are based on the 94 instances the United States voted either Yes or No in Plenary, on the motion in the Third Committee, and on the resolutions from the emergency special sessions. Columns show the number of times the United States and the pertinent country cast identical (Yes/Yes or No/No) and opposite (Yes/No or No/Yes) votes, as well as the number of times a country abstained or was absent for these 94 votes. Voting coincidence percentages are derived by dividing the number of identical votes by the total of identical and opposite votes, the same method used in all previous editions of this report. The column headed “Voting Coincidence (Including Consensus)” presents the percentage of voting coincidence with the United States after including consensus resolutions as additional identical votes. Extent of participation was also factored in (see Introduction: Format and Methodology).

Section III contains five parts: (1) lists of UN member states alphabetically and in rank order by voting coincidence percentage; (2) lists of countries by UN regional group, in rank order by voting coincidence percentage; (3) lists of countries by other groupings, again in rank order; (4) a comparison of 2006 votes only percentages with those of the preceding five years; and (5) a side-by-side comparison of each country’s voting coincidence with the United States and a calculation of the amount of bilateral U.S. assistance provided to that country in fiscal year 2006 (from the Foreign Operations, Export Financing, Related Programs Act and P.L. 480 funds) and that country’s assessment percentage of the UN budget for 2006. General Assembly Resolution 61/237 (2006) set out the scale of assessments for the period 2007—2009, maintaining the same methodology used for the period 2004—2006 and, based on intensive U.S. diplomatic efforts, maintaining the 22 percent ceiling rate, established in December 2000, at which the United States is assessed.

All members voted during the session. The United States again voted No in Plenary more often than any other UN member (32 percent of U.S. No votes coincided with those of three or fewer countries), voting No alone on 18 occasions, which was higher than last year. The United States voted No with only one other country five times (twice each with Israel, and Japan, Moldova, and North Korea once each). On several other occasions, the United States was joined in a No vote by Israel and one or two other countries (usually

France and the United Kingdom; Palau and Russia joined other countries with the United States once each).

The United States voted in isolation on resolutions concerning implementation of the declaration on the granting of independence; transparency and confidence building in outer space activities; trade in small arms; rights of the child; the right to food; developments in the fields of information and telecommunications; environmental norms in arms control; peace through practical disarmament measures; towards an arms trade treaty; and the relationship between disarmament and development. The United States also voted in isolation on two paragraph votes on an arms trade treaty. Israel voted with the United States on resolutions regarding arms control, racism, decolonization, financing of the UN Interim Force in Lebanon (UNIFIL), and the U.S. embargo of Cuba. The United Kingdom voted with the United States on resolutions on decolonization and arms control. Japan voted with the United States on a paragraph vote on arms control. France and Russia voted with the United States on resolutions concerning arms control. Moldova voted with the United States on a resolution concerning international trade and development; Palau voted with the United States on the Cuba embargo and on UNIFIL financing; and North Korea voted with the United States on a resolution concerning the Comprehensive Nuclear Test-Ban Treaty.

The Palestinian Authority is not a UN member and does not have voting privileges.
